Custom Spray Tanning uses a Spray Tanning machine to apply a cosmetic tanning solution that contains dihydroxyacetone (DHA). DHA is a non-toxic sugar, derived of sugar beet and/or sugarcane. Each individual is unique, therefore clients who have sensitive skin may experience a minor rash. Hormonal changes such as the menstrual cycle and menopause can also effect the results of the spray tan. Opulence Spray Tan club cannot guarantee the results of a spray tan, as every individual is different. The solution can rub off on clothing, however the use of a mild detergent will take out stains.

If you have a skin disease(s) and are using medications, please check with your physician before receiving a spray tan. Please notify your Tanning Consultant if you've had any intense treatment such as a chemical peel or have been using strong chemical compounds on your skin.
